



Please remember the change in pick up this week due to MaryFair. <u>Because the large MaryFair tent will</u> <u>occupy the majority of the east parking lot, pick-up after school for Thursday, 10/4, and Friday, 10/5 will</u> <u>be adjusted</u> (drop-off should remain the same). The line by the rectory, exiting onto 48<sup>th</sup> Place will remain open, but the lines in the big parking lot will not be available. To help relieve the congestion caused by losing these exit lines, dismissal lines will be formed in the west parking lot. These <u>temporary</u> lines will exit onto Quaker.
