St. Mary is committed to a need-based financial aid program that enables qualified students from all cultural, racial and socioeconomic groups to attend St. Mary. Financial aid is awarded on the basis of a family's demonstrated financial need. The St. Francis of Assisi Tuition Assistance Program is awarded to families that are active parishioners enrolled at the School of St. Mary and Go for Catholic Schools is awarded to all families based on need. Because many families apply for financial aid, the School of St. Mary is not able to offer aid to all families, nor can it offer full demonstrated need.

If you are currently enrolled at the School of St. Mary, you may use your FACTS Tuition account to apply for financial aid. If you are a family new to St. Mary and do not have a FACTS Tuition account, you may apply for financial aid at: https://www.factstuitionaid.com/facts/gaindex. One application is sufficient for both the St. Francis of Assisi Tuition Assistance Program and for Go for Catholic Schools. Only online applications will be accepted. After completing the online applications, you will need to mail or fax the supporting documentation. The tax information needed to verify your application is shown in the FGAA Checklist that is found online.

The deadline for the submission of financial aid requests is April 15.

As you have probably already seen, the FACTS problem with Cafeteria and After School Care fees that we thought was fixed was not. Patty O'Meilia has been talking to the FACTS people all morning and here are the facts about the FACTS situation:

- You do not have to do anything about the most recent Cafeteria/After School Care bill no late fees will be assessed (contrary to what the email you received said).
- If you have already paid the Cafeteria/ASC bill, do not worry. You will not be billed again.
- FACTS will manually go through each account and make the accounts of people who have not paid into auto payment for Cafeteria/ASC again. Everyone will be autopay next cycle.
- The new billing date for the latest cycle of Cafeteria/ASC fees will be March 7th. This one time only. Billing should revert back to the regular date in March.
