Parental Choice Tax Credit

How-to for Parents and Guardians

The Parental Choice Tax Credit law provides refundable tax credits of \$5,000 to \$7,500 per child, per year, to help all Oklahoma families with the cost of tuition and fees at a participating private school.

Who qualifies?

The lower a family's income, the larger the tax credit. The refundable tax credit is provided in two installments, at semester.

The maximum credit for families earning:

- Up to \$75,000 is \$7,500
- \$75,001 to \$150,000 is \$7,000
- \$150,001 to \$225,000 is \$6,500
- \$225.001 to \$250,000 is \$6,000
- \$250,001 and up is \$5,000



Important 2025 Dates and Deadlines

Online applications for the 2025-2026 school year open on February 18, 2025, on the Oktap.tax.ok.gov website. Priority applications -those families whose adjusted gross income is \$150,000 or less, MUST be submitted within the first 60 days to receive priority consideration.

Requirements for Parents / Guardians

A parent or guardian must request an Enrollment Verification Number (EVN) for each student from the school the student attends or plans to attend. The EVN is used on the taxpayer's application.

Application Status Notification


After verification is completed, the taxpayer is notified by email. Applicants also can check the status of an application on the oktap.tax.ok.gov website.

Checks are Mailed to Schools

Checks are mailed to the private school. Taxpayers can either pick up the check or sign it over to the school for payment of tuition and fees






Dear Saint Mary Families,

As February gets going and we approach the opening of the Parental Choice Tax Credit application portal, I want to remind you to **make sure you have received an enrollment verification number for each of your children and that all the information is correct-**birth dates and names must be exactly as they appear on tax documents. Should you find an error, please let me know immediately so I can make the necessary corrections and request a new enrollment form be sent to you. Any errors on the enrollment verification forms must be corrected before you apply. Applications with incorrect information will be rejected. The application portal will open on Tuesday, February 18, 2025 at 9:00 AM. I am attaching information regarding the application process. Applications are for the 2025-26 school year, and every family must reapply for each child. Below you will find information and resources from the tax commission.

The taxpayer application for school year 2025-2026 will be available for taxpayers to complete beginning on **Tuesday**, **February 18**, **2025**, at **9 a.m.**

- Due to the high volume of applications and call volume expected, applicants should allow up to 6 hours to receive their submission confirmation emails and should expect longer wait times for any inquiries.
- Applications with a priority status (those with a Federal Adjusted Gross Income of \$150,000 or less) will be reviewed during the priority period.
- → The priority period is 60 days from the application open date, February 18, 2025, at 9 a.m. through April 19, 2025, at 9 a.m.
- → Priority applications will be reviewed and notified within 30 days from the date of the submission.
- → After all priority applications submitted during the priority period have been reviewed and a final determination is made, all other applicants can expect to be notified of their status within approximately 30 days of the priority period ending or within 30 days of application submission if submitted at a later date. Please note, each application is unique, and as such, a manual review may be conducted to ensure accuracy.
